I, _____, hereby consent and authorize the Boys & Girls Clubs of the Twin Cities and its affiliates, agents, or representatives (the "Club"), to obtain or cause to be prepared information pertaining to my character, general reputation, personal characteristics, mode of living and background for employment purposes. I authorize the Club to make an independent investigation of my background, references, character, past employment, education, credit history, social security number verification, criminal or police records, driving history, court cases, and judgments, including those maintained by both public and private organizations and all public records, for the purpose of confirming the information contained on my applications and/or obtaining information which may be material to my qualifications for employment, volunteer status, or service with the Club. I also understand that in the event I am hired for employment, the Club may conduct a background check periodically.

I authorize any person, school, organization, current employer, prior employer, courthouse, public agency, law enforcement agency, or other entity or organization to provide the Club with any information and opinion requested in connection with my application, regardless of whether such person, business entity, or governmental agency compiled the information itself or received it from other sources. I understand that the information supplied by me and such persons and entities can be utilized in conducting a background investigation, which may include, but not be limited to, a consumer credit report, criminal history search, driving record history, and verification of any information provided on my application. These investigations may include personal interviews with neighbors, friends, or associates of mine or others with whom I am acquainted or who may have knowledge concerning any such items of information.

I understand that before I am denied employment or other adverse action is taken against me based on information in the report, I will be provided a copy of the report and a description in writing of my rights under the Fair Credit Reporting Act (“FCRA”). Under the FCRA, I have the right to make a written request, within a reasonable period of time, to the Club for a complete and accurate disclosure of the nature and scope of any investigative consumer report pursuant to 15 U.S.C. § 1681d(b). I may also request a written summary of my rights under the FCRA pursuant to 15 U.S.C. § 1681g(c).

In addition to my rights under the FCRA, I understand that under Club policy, if I disagree with the accuracy of any information in the report, I may notify the Club within five (5) business days of my receipt of the report of the basis for my disagreement with its accuracy.

By my signature below, I hereby authorize the Club to:

- (1) make whatever inquiries it deems necessary to evaluate my qualification for employment and/or continuing employment;
- (2) contact consumer reporting agencies and any other person or agency which may have information about me, including former employers and other references; and
- (3) obtain or cause to be prepared a consumer report and/or investigative consumer report on me in connection with my application for employment and continued employment.
